- 1) The City Government of Tayabas, through the Annual Budget - 20% Development Fund intends to apply the sum of Nine Hundred Ninety-Eight Thousand Nine Hundred Forty and 88/100 Pesos (Php 998,940.88) being the Approved Budget for the Contract (ABC) to payments under the contract for each lot. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.
- 2) The City Government of Tayabas now invites bids for PROJECT # 26-031 IMPROVEMENT OF MULTI-PURPOSE BUILDING – BRGY. GIBANGA, TAYABAS CITY.4 Completion of the Works is required within Eighty-Three (83) CD upon receipt of Notice to Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders (ITB).
- 3) Bidding will be conducted through competitive bidding procedures using a non- discretionary "pass/fail" criterion as specified in the IRR, otherwise known as the "New Government Procurement Act (NGPA)".
- 4) Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 5) The contract will be awarded to the Lowest Calculated Responsive Bid (LCRB).
- 6) Interested bidders may obtain further information from City Government of Tayabas and inspect the Bidding Documents at the address given below from 8:00 a.m. to 5:00 p.m.
- 7) A complete set of Bidding Documents may be acquired by interested bidders on April 8, 2026 (Wednesday) from

the address given below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of One Thousand Pesos (P 1,000.00).

8) It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

9) Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through manual submission at the address indicated below or (ii) online or electronic submission through the electronic bidding facility of the PhilGEPS, as indicated below on or before April 15, 2026 (Wednesday) 10:00 a.m.. Late bids shall not be accepted.

10) All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 16.

11) Bid opening shall be on April 15, 2026 (Wednesday) 10:01 a.m. at Bids and Awards Committee Office, 2nd floor New City Hall Building, Brgy. Baguio, Tayabas City and/or via. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.

12) The Procuring Entity is the City Government of Tayabas with email address of bac@tayabas.gov.ph for the use of a back-up data or cloud storage for large files uploaded for online bid submission.

13) The City Government of Tayabas reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 70 of R.A.No.12009, without thereby incurring any liability to the affected bidder or bidders.
